GENERAL INFORMATION:

1. Practice gym will be available.

2. Freestyle events in our open contest are designed to accommodate all organizations and styles of twirling. Acro is allowed. Each contestant will receive a comment sheet and participants will be ranked for placement. Divisions will be determined based on entries received.

3. Schedule: Saturday: NBTA State Solo Competition& OPEN Solo Competition including show twirls and rhythmics, Sunday Morning: State & Open Team Competition. More exact contest times to come a week prior once entries are received.

4. Soft rubber soles on gym floor.

5. Directors send in team entries & group roster.

6. <u>STATE CONTEST DEADLINE:</u> February 17th, 2024. NO LATE STATE ENTRIES WILL BE ACCEPTED. Sorry, NO Refunds.

7. <u>OPEN CONTEST DEADLINE</u>: February 23rd, 2024. If entry for <u>open events</u> is postmarked after 2/17/24, include late entry fee of \$5.00 per event entered. Late entries must be received by February 23rd, 2024. Sorry, No Refunds.

8. In the spirit of safety, courtesy, and fairness to all, NBTA encourages voluntary cooperation limiting video taping to: (A) Parent videotaping own child (B) Teacher videotaping own student (C) Group Director/appointed person videotaping own group or corps (D) Safety first applies, no tripods, extension cords or artificial lights. Common sense prevails. No videotaping will be permitted in immediate area behind or around judges or official contest tables.

9. No flash photography will be allowed in the gym areas.

10. <u>Admission for contest</u>: In order to eliminate lines to enter the building, there is a processing fee of \$15.00 that has to be included with each entry. This fee applies to individual team members as well. If there is more than one child in a family competing, or if your child is in teams and solos, then only one processing fee will be paid. This is a flat fee that includes the State & Open Contest.
